





## Minutes of Pre-Bid Meeting: E-Tender for Supply and Installation of Raised Access floor Panels / System at CVPS and ODC, Main Office Building, Belapur, Navi Mumbai (RBI/Belapur Regional office/Estate/5/24-25/ET/503).

The Pre-Bid meeting for the captioned tender was held on November 07, 2024, at 11:00 hrs. One firm participated in the Pre-bid meeting. Name of the participant is given in <u>Annex-1</u>.

2. AGM (Estate) in his inaugural address welcomed the representative of the firm and briefed the forum about the captioned work. The Bank Officials also explained various aspects of the tender which needs to be taken care of by all the intended bidders during submission of their bids. Thereafter, all the doubts / queries of the firm(s) were discussed in detail.

3. Doubts / queries of the firm along with the clarifications provided by the Bank are tabulated hereunder:

		iii) What is the framework height from the floor for BoQ item no. 02?	iii) It was clarified that the framework of the system should be approximately 600 mm in height for BoQ item no. 02.
