- (7) The PWD candidates may belong to any category (i.e. General/SC/ST/OBC). 'Backlog reserved vacancies' for PWD are horizontal and within the overall vacancies for the post.
- (8) At the time of written examination, only those PWD candidates, who have physical limitation in writing, including that of speed, would be allowed the facility to use the service of a scribe/writer. In all such cases where a scribe/writer is used, the following rules will apply:
