**Subject: Continuation of Interest Subvention Scheme for Short Term Crop Loans during the year 2017-18- Budgetary allocation---regarding.**

Madam/Sir,

I am to refer to this Department's letter of even No. dated 17<sup>th</sup> July, 2017 wherein the approval for continuation of Interest Subvention Scheme (ISS) during the current financial year i.e. 2017-18 has been conveyed and to inform that whereas till 2016-17, the Interest Subvention Scheme was implemented as Non Plan and no category-wise budget allocations viz. General, Scheduled Caste (SC), Scheduled Tribe (ST), North Eastern Region (NER), NER-(SC), NER (ST) were provided under the Scheme, however, from the current financial year i.e. 2017-18, the Plan – Non Plan categorization of schemes has been dispensed with. Accordingly, all claims under ISS are required to be settled as per the following budget allocation as applicable in case of Plan Scheme: --

2. Out of above mentioned budgetary allocations, funds of Rs.3941.89 crore (from General category) have already been released by this Department in the current financial year to RBI and NABARD to settle the pending claims of previous years.

3. Since, in the current financial year the funds under Interest Subvention Scheme have been allocated category wise, the RBI and NABARD are requested to furnish further claims category wise as mentioned above so as to facilitate this department to utilize the entire budgetary allocations.
