While <u>existing PAs</u> (that have applied for authorisation within the stipulated timelines) can continue business unless advised otherwise by the Reserve Bank of India, <u>new PAs</u> cannot commence operations until they are granted 'authorisation' under Section 7 of the Payment and Settlement Systems Act, 2007.
