EXPLANATION OF CHANGES IN NEW LIST FORMAT

The key change in the Al-Qaida Sanctions List is the amendment of the old reference numbering system to a newer referencing system that is harmonized with all other United Nations Sanctions Committees. Examples for individuals and entities are provided below:

Individuals:

To illustrate, for the individual: Nashwan Abd Al-Razzaq Abd Al-Baqi former reference number **(QI.A.12.01.)**

QI. read as follows: Q = Al-Qaida and I = Individual;

.A. = the initial of the individuals last name;

.12. = the sequential number available at the time of listing;

.01. = the year of listing.

In the new reference scheme, the individual's last name initial and the year of listing have been removed. QI has been replaced with QDi (QD = Al-Qaida and i = individual). The sequential numbering is maintained. The new permanent reference number for the above individual would therefore now read: **(QDi.012)**.

Further examples are provided below:

QI.H.10.01	Zayn al-Abidin Muhammad Hussein	QDi.010

Entities:

To illustrate, for the entity: Abu Sayyaf Group former reference number **(QE.A.1.01.)**

QE. read as follows: Q = Al-Qaida and E = entity;

.A. = the first letter of the entity's name;

.1. = the sequential number available at the time of listing;

.01. = the year of listing.

In the new reference scheme, the entity's first name initial and the year of listing have also been removed. QE has been replaced with QDe (QD = Al-Qaida and e = entity). The sequential numbering is maintained. The new permanent reference number for the above entity would therefore now read:

(QDe.001).
