

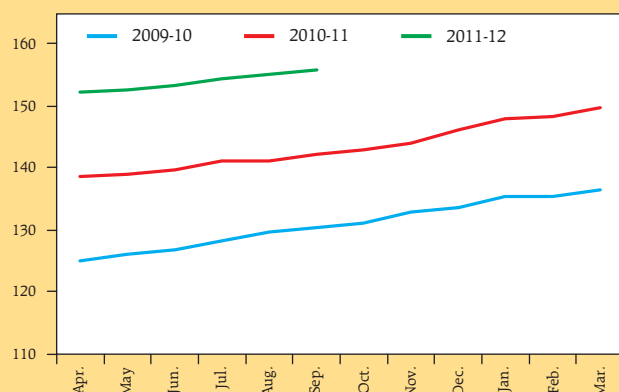

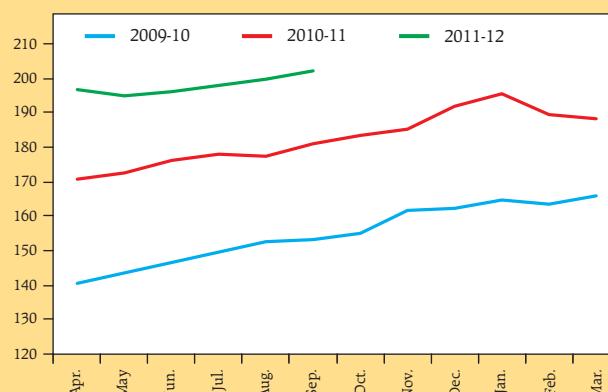

WPI-All Commodities**



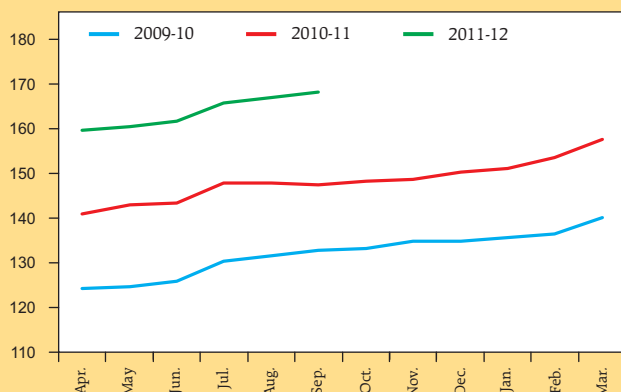
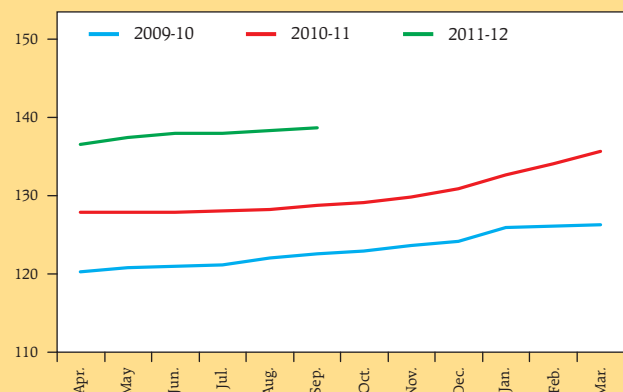
**Monthly Movement in the Index of
