

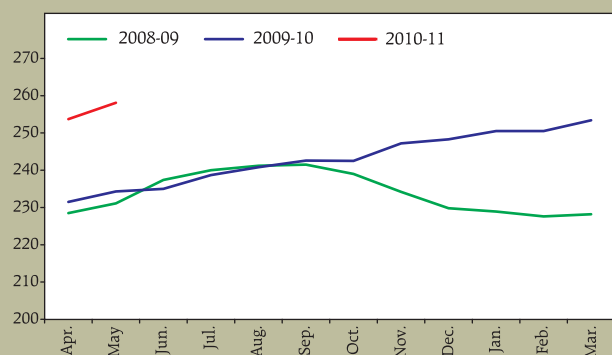

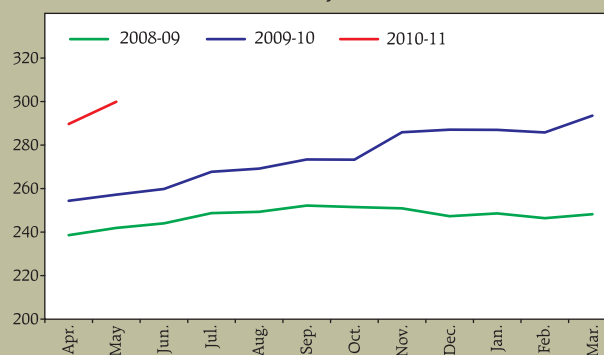

WPI-All Commodities



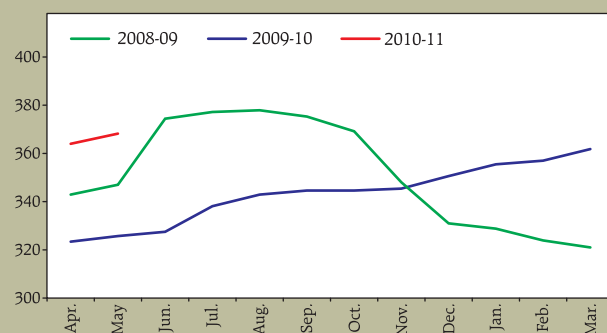
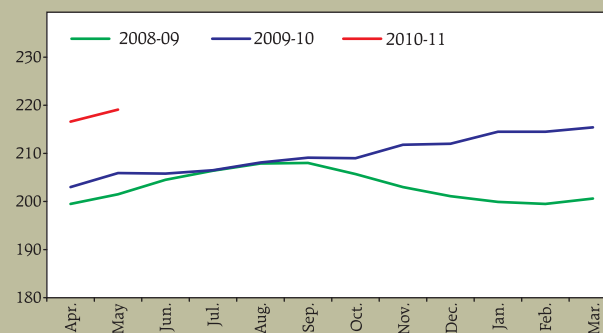
Monthly Movement in the Index of
