## Deregulation of Interest Rates on Non-Resident (External) Rupee (NRE) Deposits

Please refer to our <u>circular RPCD.CO.RRB.BC.No.24/03.05.33/2013-14 dated August 19, 2013</u> allowing banks the freedom to offer interest rates on incremental NRE deposits with maturity of 3 years and above without any ceiling in order to pass on the benefit of exemption provided on such deposits from CRR/ SLR requirements. In terms of para 4 thereof, these instructions are valid up to November 30, 2013, subject to review.

- 2. In this connection, we advise that the above instructions issued vide circular under reference will remain unchanged till January 31, 2014, subject to review.
- 3. An amending directive RPCD.CO.RRB.Dir.No.66 /03.05.33/2013-14 dated December 2, 2013 is enclosed.
