Implementation of Section 51-A of UAPA, 1967- Updates of the UNSCR 1267(1999) / 1989(2011) Committee's AI Qaida Sanctions List

Please refer to our <u>circular DBOD.AML No.6440/14.06.001/2014-15 dated October</u> <u>30, 2014</u> on the captioned subject releasing 19<sup>th</sup> update dated October 28, 2014 regarding UNSCR 1267(1999) / 1989(2011) Committee's AI Qaida Sanctions List.

Banks/All India Financial Institutions are required to update the list of individuals/entities as circulated by Reserve Bank and before opening any new account, it should be ensured that the name/s of the proposed customer does not appear in the list. Further, banks should scan all existing accounts to ensure that no account is held by or linked to any of the entities or individuals included in the list.

4. Banks are advised to strictly follow the procedure laid down in the UAPA Order dated August 27, 2009 enclosed to our <u>circular DBOD.AML.BC.No.</u> <u>44/14.01.001/2009-10 dated September 17, 2009</u> and ensure meticulous compliance to the Order issued by the Government.

"Caution: RBI never sends mails, SMSs or makes calls asking for personal information like bank account details, passwords, etc. It never keeps or offers funds to anyone. Please do not respond in any manner to such offers."

5. As far as freezing of funds, financial assets or economic resources or related services held in the form of bank accounts of the designated individuals/entities are concerned, action should be taken as detailed in paragraph 6 of the circular dated September 17, 2009, mentioned above.
