## Implementation of Section 51-A of UAPA, 1967-Updates of the UNSCR 1267(1999) / 1989(2011) Committee's AI Qaida Sanctions List

Please refer to our <u>circular DBOD. AML No. 7299/14.06.001/2012-13 dated</u> <u>November 19, 2012</u> on the captioned subject. We have since received from Government of India, Ministry of External Affairs, UNP Division, <u>copy of notes dated</u> <u>November 23, 26, 27</u>, and <u>December 5, 2012</u>, (copies enclosed) forwarded by the Chairman of UN Security Council's 1267/1989 Committee regarding changes made in the "Al-Qaida Sanctions List", i.e. list of individuals and entities linked to Al-Qaida.

2. Banks/All India Financial Institutions are required to update the list of individuals/entities as circulated by Reserve Bank and before opening any new account, it should be ensured that the name/s of the proposed customer does not appear in the list. Further, banks should scan all existing accounts to ensure that no account is held by or linked to any of the entities or individuals included in the list.

3. Banks are advised to strictly follow the procedure laid down in the UAPA Order dated August 27, 2009 enclosed to our <u>circular DBOD.AML.BC. No.</u> <u>44/14.01.001/2009-10 dated September 17, 2009</u> and ensure meticulous compliance to the Order issued by the Government.
