## Implementation of Section 51-A of UAPA, 1967 - Updates of the UNSCR 1267(1999) / 1989(2011) Committee's AI Qaida Sanctions List-Primary (Urban) Co-operative Banks(UCBs)

Please refer to our <u>circular UBD.BPD.PCB.Cir.No.17/14.01.062/2014-15</u> <u>dated September 17, 2014</u> on the captioned subject releasing 16th update dated September 9, 2014 regarding UNSCR 1267(1999) / 1989(2011) Committee's Al Qaida Sanctions List.

2. Ministry of External Affairs (MEA), UNP Division has forwarded two updates, one regarding addition of name of fourteen individuals and two entities to the sanction list and another regarding amendment to the entry in the sanction list. UCBs are required to update the list of individuals / entities as circulated by Reserve Bank and before opening any new account, it should be ensured that the name/s of the proposed customer does not appear in the list. Further, banks should scan all existing accounts to ensure that no account is held by or linked to any of the entities or individuals included in the list.

4. UCBs are advised to strictly follow the procedure laid down in the UAPA Order dated August 27, 2009 enclosed to our <u>circular</u> <u>UBD.CO.BPD.PCB.Cir.No.21/12.05.001/2009-10 dated November 16, 2009</u> and ensure meticulous compliance to the Order issued by the Government.

5. As far as freezing of funds, financial assets or economic resources or related services held in the form of bank accounts of the designated individuals / entities are concerned, action should be taken as detailed in <u>paragraph 7</u> of the circular dated November 16, 2009, mentioned above.
