**Formation of nine new Districts in the State of Chhattisgarh -
Allotment of Lead Responsibility**

The Revenue Department, Government of Chhattisgarh vide their Notification No. F-6-292/Seven-3/2011 dated December 27, 2011 (Serial Number 332) had notified the formation of nine new districts in Chhattisgarh State viz. Sukma, Kondagaon, Balodabazar, Gariyaband, Bemetara, Balod, Mungeli, Surajpur and Balrampur with effect from January 01, 2012. It has been decided to assign the lead bank responsibilities of the new districts as detailed below:-
