Implementation of Section 51-A of Unlawful Activities Prevention Act (UAPA), 1967-12th Update of Al-Qaida Sanctions List

Please refer to our [circular DBR.AML.No.17668/14.06.001/2014-15](http://www.rbi.org.in/circular/DBR.AML.No.17668/14.06.001/2014-15) dated **May 20, 2015** on the captioned subject releasing the 12th update dated May 18, 2015 regarding UNSCR 1267(1999)/ 1989(2011) Committee's Al Qaida Sanctions List.

2. Ministry of External Affairs (MEA), UNP Division has forwarded the 13th update dated May 22, 2015 regarding amendment to an entry from the sanction list ([copy enclosed](#)). Regulated Entities (REs) are required to update the list of individuals/entities as circulated by Reserve Bank and before opening any new account, it should be ensured that the name/s of the proposed customer does not appear in the list. Further, banks should scan all existing accounts to ensure that no account is held by or linked to any of the entities or individuals included in the list.

4. REs are advised to strictly follow the procedure laid down in the UAPA Order dated August 27, 2009 enclosed to our [circular DBOD.AML.BC.No.44/14.01.001/2009-10](#) dated September 17, 2009 and ensure meticulous compliance to the Order issued by the Government.
