**Formation of seven new districts in the State of Gujarat -  
Assignment of Lead Bank Responsibility**

The Government of Gujarat vide The Gujarat Government Gazette Notification No. GHM/2013/69 to 75 /M/PFR/102013/139/L.I dated August 13, 2013 had notified the formation of seven new districts in the State of Gujarat.
