UCBs - Section 42(1) of Reserve Bank of India Act, 1934-Maintenance of Cash Reserve Ratio (CRR)

Please refer to our Circular <u>UBD (PCB) Cir. No.9/ 12.03.000/ 2008-09</u> dated January 05, 2009 on the captioned subject.

2. On the basis of the current macroeconomic assessment, as set out in the <u>Third</u> <u>Quarter Review of the Monetary Policy 2009-10</u> issued on January 29, 2010, it has been decided to increase the Cash Reserve Ratio (CRR) for Scheduled Primary (Urban) Cooperative Banks by 75 basis points from 5.00 per cent to 5.75 per cent of their net demand and time liabilities (NDTL), in two stages, effective from the fortnights as indicated below.
