Liquidity Adjustment Facility – Repo and Reverse Repo and Marginal Standing Facility Rates

As announced in the <u>Mid-Quarter Monetary Policy Review: June 2011</u>, it has been decided to increase the repo rate under the Liquidity Adjustment Facility (LAF) by 25 basis points from 7.25 per cent to 7.50 per cent with immediate effect.

2. Consequent to the above increase in the repo rate, the reverse repo rate under the LAF will stand automatically adjusted to 6.50 per cent and the Marginal Standing Facility (MSF) rate to 8.50 per cent with immediate effect.

3. All other terms and conditions of the current LAF and MSF Schemes will remain unchanged.
