**Formation of new district in the State of Chhattisgarh – Assignment of Lead Bank Responsibility**

The Government of Chhattisgarh vide Gazette Notification No. F11-04/2019/Seven-4 dated December 30, 2019 had notified the formation of one new district viz. Gaurela-Pendra-Marwahi in the State of Chhattisgarh with effect from February 10, 2020. It has been decided to assign the lead bank responsibility of the new district as under:
