Banks/All India Financial Institutions are required to update the list of individuals/entities as circulated by Reserve Bank and before opening any new account, it should be ensured that the name/s of the proposed customer does not appear in the list. Further, banks should scan all existing accounts to ensure that no account is held by or linked to any of the entities or individuals included in the list.

4. Banks are advised to strictly follow the procedure laid down in the UAPA Order dated August 27, 2009 enclosed to our <u>circular DBOD.AML.BC. No.</u> <u>44/14.01.001/2009-10 dated September 17, 2009</u> and ensure meticulous compliance to the Order issued by the Government.
