It may be recalled that the guidelines for licensing of "Small Finance Banks" and "Payments Banks", issued on November 27, 2014, indicated that the applications for small finance banks and payment banks will be initially screened by the Reserve Bank to ensure *prima facie* eligibility of the applicants. An External Advisory Committee (EAC) comprising eminent professionals like bankers, chartered accountants, finance professionals, will evaluate the applications thereafter and that the names of the members of the EAC will also be placed on the Reserve Bank's website.
