Reserve Bank of India imposes monetary penalty on Mula Sahakari Bank Ltd., Sonai, Ahmednagar (M.H.)

The Reserve Bank of India (RBI) has imposed, by an order dated February 11, 2022, a monetary penalty of ₹25,000/- (Rupees Twenty five Thousand only) on Mula Sahakari Bank Ltd., Sonai, Ahmednagar (the bank) for contravention of/ non-adherence with Directions issued by RBI to Urban Co-operative Banks on Exposure Norms & Statutory/Other Restrictions-UCBs. This penalty has been imposed in exercise of powers vested in RBI under the provisions of Section 47 A (1) (c) read with Section 46 (4) (i) and Section 56 of the Banking Regulation Act, 1949, taking into account the failure of the bank to adhere to the aforesaid directions issued by RBI.

This action is based on deficiencies in regulatory compliance and is not intended to pronounce upon the validity of any transaction or agreement entered into by the bank with its customers.

Background

The inspection report of the bank based on its financial position as on March 31, 2020, revealed, *inter alia*, that the bank had not adhered to prudential inter-bank counter party limit as prescribed under Directions issued by RBI on Exposure Norms & Statutory/Other Restrictions-UCBs. Based on the same, a Notice was issued to the bank advising it to show cause as to why penalty should not be imposed for noncompliance with the directions.

After considering the bank's replies and oral submissions made during personal hearing, RBI came to the conclusion that the aforesaid charge of non-compliance with RBI directions was substantiated and warranted imposition of monetary penalty.
