Financial Action Task Force (FATF) Public Statement dated October 21, 2016

The Financial Action Task Force (FATF) has called on its members and other jurisdictions to apply counter-measures to protect the international financial system from the on-going and substantial money laundering and terrorist financing (ML/FT) risks emanating from the jurisdiction of Democratic People's Republic of Korea (DPRK). Jurisdiction of Iran is subject to the FATF call on its members to apply enhanced due diligence measures proportionate to the risks arising from the jurisdiction. FATF has further identified the following jurisdictions as having strategic deficiencies and have developed an action plan within the FATF to deal with them. These jurisdictions are: Afghanistan, Bosnia and Herzegovina, Iraq, Lao PDR, Syria, Uganda, Vanuatu and Yemen. FATF has further identified Guyana as jurisdictions no longer subject to its on-going global AML/CFT compliance process given the significant progress made by them in improving its AML/CFT regime.
