## Underwriting Auction for sale of Government Securities for ₹31,000 cr on August 13, 2021

The Government of India has announced the sale (re-issue) of Government Stock detailed below through auctions to be held on August 13, 2021.

As per the extant scheme of underwriting notified on November 14, 2007, the amounts of Minimum Underwriting Commitment (MUC) and the minimum bidding commitment under Additional Competitive Underwriting (ACU) for the underwriting auction, applicable to each Primary Dealer (PD), are as under:

The underwriting commission will be credited to the current account of the respective PDs with RBI on the date of issue of securities.
