

Tenderers who fulfil the eligibility criteria and agree to the other terms and conditions mentioned in this document shall apply online in the prescribed form (Annex I) by 02:00 PM on August 29, 2025. The Bank reserves the right to accept any or reject any or all the applications received without assigning any reasons.

The Bank will host the tendering process online through e-Tendering web portal www.mstcecommerce.com.

#### 1. EVALUATION

#### A. TECHNICAL EVALUATION:

#### I Eligibility

#### a) Composition of the tenderers:

The chemist must hold valid licenses as on the date of application in specified forms (Form 20, 20-B, 21, 21-B and 21-C or any other relevant form under the law) for various categories of allopathic medicines issued by the Drug Control Authority of the State under the provisions of Drugs and Cosmetics Act, 1940 and Rule,1945 as applicable and any other law in force. They must hold all other licenses, clearances and permissions as may be necessary to carry out the trade of dealing with / selling of medicine. The chemists will further ensure and undertake that their licenses remain valid till the end of the contract period.

#### b) Work Experience:

The tenderer shall have minimum 3 years' experience of executing medicine supply work to Reserve Bank of India or other organisation, ending last day of month previous to the one of which applications are invited. Tenderer should furnish their client list showing the details of work carried out by them during the last 3 years.

#### c) Minimum value of each completed work/s:

The tenderers shall have successfully completed similar work/s during last 3 years ending last day of month previous to the one of which applications are invited, as under-

i) Three similar completed works each of value not less than ₹26,00,000/-(Rupees Twenty-Six lakh only)

OR



- ii) Two similar completed works each costing not less than ₹32,50,000/- (Rupees Thirty-Two lakh and Fifty Thousand only)
   OR
- iii) One similar completed work costing not less than ₹52,00,000/- (Rupees Fifty-Two lakh only)

#### d) Financial Soundness:

Minimum yearly turnover of not less than ₹65,00,000/- (Rupees Sixty-Five Lakhs only) in the last three financial years.

#### e) Solvency:

The tenderers should furnish Solvency Certificate issued by the applicant's banker, specifically for the purpose of this medicine supply work for a minimum amount equal to the estimated supply of ₹65,00,000/- (Rupees Sixty-Five Lakhs only).

#### f) Non-Conviction/ Debarment:

- i) The tenderers must not have been convicted by the State Drugs Authorities and no case should be pending against them under the Drugs and Cosmetics Act 1940 and Rules made thereunder as well as under the Drugs (Price Control) Order 1955 or Drugs (Price Control) Order, 2013 or any other Orders issued or any other laws in force from time to time. The Chemist shall bear good character and should not be convicted of any offence under any other law.
- ii) The tenderers should not have been debarred / blacklisted by any Govt./ Semi-Govt./ Public Sector organization.
- iii) The tenderers shall give details of all disputes he/she had with his/her clients and furnish the status thereof. In absence of the same, a declaration to that effect to be furnished.

#### g) Service Setup:

The chemist must have a shop / establishment within Bhubaneswar Municipal Corporation limits.

#### h) Billing System:

The chemist should have a computerized billing system.

#### i) MSTC Registration:

The chemist should be registered with MSTC portal.



#### II Documents establishing eligibility:

The following documents must be submitted along with the application:

- a) Self-attested copies of:
  - i. Copy of Registration of the company/ partnership/ proprietorship
  - ii. Valid licenses held by the chemist as on the date of application
  - iii. Copy of GST registration Certificate
  - iv. Copy of PAN allotted to the chemist.
- b) Client list showing details of work carried out by them during the last three (03) years as per <u>Annex IV</u> with the copy of work orders, to establish work experience as specified in para I (b) above.
- c) Copy of No Conviction Certificate from State Drugs Controller that the chemist/ firm has not been convicted of any offence under the Drugs and Cosmetics Act and Rules made thereunder and no case is pending against the firm / chemist under the Drugs and Cosmetics Act and Rules made there under as well as under the Drugs (Price Control) Order, 1995 or Drug (Price Control) order 2013 or other orders issued from time to time. An affidavit to the effect duly notarised is acceptable in lieu thereof.
- d) Copies of balance sheets for the last three (03) financial years (2024-25; 2023-24 and 2022-23), duly certified by a Chartered Accountant and IT returns for the corresponding assessment years.
- e) Client report/ certificate from each of the qualifying work from clients as mentioned in para II (b) above, as per specified format in <u>Annex V</u>.
- f) Banker's certificate from the tenderers' banker as per format in Annex II.
- g) Tenderers should submit **documentary evidence of the shop/ establishment** within Bhubaneswar Municipal Corporation limits.
- h) Tenderers should submit the **details of their banker and bank account** details along with a cancelled cheque of the account, as per <u>Annex III</u>.

In addition to the documents mentioned above, the Bank reserves its right to call for additional documents, if required, at any point of time.



#### **III** Earnest Money Deposit (EMD):

a) The expected procurement value during the contract period is estimated at ₹65,00,000/(Rupees Sixty-Five Lakhs only). The tenderers shall deposit EMD of 2% of the value of
expected procurement value i.e., ₹1,30,000/- (Rupees One lakh Thirty Thousand only)
which shall be remitted to the below mentioned bank account of Reserve Bank of India,
Bhubaneswar through NEFT/ RTGS. Proof of remittance with transaction number
(scanned copy) shall be attached/ uploaded along with Part I documents. The
tenderers are also advised to send the proof of remittance with transaction
number (scanned copy) to email ID of RBI contact persons mentioned in para A of
Section III.

- b) Under no circumstances, EMD shall be accepted in any other form than stipulated above. A bid which is not accompanied by EMD, shall not be considered and shall be rejected. Failure to comply with the conditions will render the tender void and the tender will be rejected. The EMD of tenderers other than successful tenderer shall be returned after the completion of the tender process. No interest will be paid on the EMD. The EMD of successful tenderer shall be released after submission of Performance Bank Guarantee (which is 5% of the expected procurement value).
- c) The EMD shall be forfeited (i) if the tenderer withdraws bid after opening of the price bid, (ii) if upon award of work, the successful tenderer fails to commence the work within 7 days, (iii) if the tenderers do not honour their commitment. Such tenderers shall also be liable to be debarred from participating in any future tender or undertaking any work in the Bank for a period of three years. However, before debarring such bidder, the Bank shall give notice and consider the reply, if any, given by the bidder.

Note: Tenderers are advised to remit EMD well in advance to avoid last minute hassle.



#### IV PERFORMANCE BANK GURANTEE (PBG) / SECURITY DEPOSIT (SD):

- a) As a security for due fulfilment of the terms and conditions and obligations of the service contract, the successful bidder shall submit a Performance Bank Guarantee (PBG) of 5% of the value of expected supply i.e., ₹3,25,000/- (Rupees Three lakh and Twenty-Five Thousand only) within fifteen (15) days of award of work as per format prescribed in Annex VI or amount equivalent to PBG may be submitted as Security Deposit (SD) through online mode (NEFT/ RTGS) to the bank account as mentioned at para III (a) above for the entire period of currency of contract period.
- b) In case of breach of any terms and conditions attached to this contract, the PBG/ SD of the tenderer shall be liable to be invoked/ forfeited besides annulment of the contract. If the bidder fails to furnish the prescribed PBG/ SD within the prescribed period specified above, Reserve Bank of India or its successors, in office shall without prejudice to any other right or remedy, be at liberty to forfeit the said earnest money absolutely. Further, if the successful bidder fails to commence work as specified in Section V of the tender document, Reserve Bank of India or its successors in office shall without prejudice to any other right or remedy available in law, be at liberty to invoke/ forfeit the said PBG/ SD absolutely. The said PBG/ SD shall be a guarantee to execute all the works referred to in the tender document upon the terms and conditions contained therein. Further, in case the PBG / SD is invoked / forfeited as aforesaid, the bidder shall be debarred from participation in the re-tendering process of the work.
- c) The PBG should remain valid up to six (06) months beyond the validity of the contract. Similarly, the SD shall be retained up to six (06) months beyond the validity of the contract.
- d) The EMD deposited by the successful tenderer at the time of submission of the tenders will be returned on submission of the PBG in lieu of security deposit as stated above.
- e) The PBG/SD shall be released without interest after six (06) months of completion of the contract period only after the Bank being satisfied of the successful completion of the contract and if there are no liabilities from the tenderer to the Bank. In case of any complaint or pending dues, the PBG/SD shall be discharged only after adjusting all dues, liabilities, etc. thereof.
- f) In case of delays in submission of PBG/SD, charges for delay (penalty) in submission of PBG shall be recovered from the bills of the supplier at Bank Rate.
- g) The amount of PBG / SD shall be liable to be invoked / forfeited under the following conditions:
  - i. In case of non-commencement of work
  - ii. In case of non-performance of contract obligations or failure to comply with any of the conditions of the contract, over charging or delivery with substantial delays beyond the prescribed period
  - iii. If the medicines supplied by the authorized chemist against the Supply Order placed on them in pursuance of this contract are subsequently found as having been stolen, sub-standard, spurious medicines or substitute medicines or not conforming to quality
  - iv. Non-adherence to offered discount
  - v. Discrepancies in billing



#### B. PRICE EVALUATION

- 1. The tenderers shall upload **Form of Tender** (Section VI) duly filled, signed and stamped by **authorized official and Financial / Price Bid** ((Section VII) (Part II) online in the MSTC portal. <u>Price bids will be opened only for those tenderers who are found qualified / eligible after technical evaluation.</u>
- 2. The prices must be quoted in the **Financial / Price Bid** in Part II (Section VII) online on MSTC only.
- 3. (i) The tenderers shall quote uniform discount on MRP printed on Strip/ Bottle/ Unit packed in percentage term in respect of all items of supplies to be made under the Contract irrespective of their brands or manufacturers.
  - (ii) The quoted offer shall remain valid for the entire duration of the contract.
  - (iii) It should be noted that liability to pay any duties, levies, royalties or taxes leviable under the law by Central or State Governments or any other tax applicable in respect of the contract would be that of the chemist and the Bank will not entertain any claim whatsoever in respect of the same.
  - (iv) The Bank is not responsible for payment of GST for the service rendered by the chemist. It is the responsibility of the chemist to pay the GST to the tax authority. The vendor shall strictly comply with submission of GST and other returns also. The documentary evidence should be submitted to the Bank as per extant instructions.
  - (v) Income Tax, TDS on GST or any other taxes levied by the Government shall be deducted as applicable and RBI shall not entertain any claim whatsoever in respect of the same.
  - (vi) The tenderer will also have to bear all the expenses etc. connected with proper packaging, carting, transportation etc. in connection with supply of medicines to the dispensaries as specified by the Bank from time to time.
- 4. The Bank will only pay the labelled MRP minus discount allowed thereon after deducting the applicable taxes. The quoted offer shall remain valid for the entire duration of the contract.
- 5. All the prices quoted shall be in Indian Rupees (INR). The prices quoted shall be deemed to be for the whole work and shall be firm and binding without any escalation whatsoever for the entire contract period.
- 6. The Bank does not bind itself to accept the highest bidder and reserves the right to reject part or any or all the tenders received without assigning any reason thereof. No correspondence in this regard will be entertained. Incomplete tenders in any respect or prescribed conditions not fulfilled are liable to be rejected. Canvassing in any form by the tenderer will result in rejection of their tenders.
- 7. Bids not submitted as per the illustrative format given in Financial / Price Bid (Part II) online on MSTC portal or violating any one or more of the above-mentioned criteria will summarily be rejected.



#### C. EVALUATION OF BIDS:

The Bank will first scrutinize the eligibility of the Bidders as per the "eligibility criteria" (Refer Section IV) of the Tender Document. The decision of Bank in this regard shall be final and no further correspondence in this regard will be entertained.

The evaluation of the Technical and Financial Bids will be as indicated below:

#### I Technical Evaluation

- a) The technical bids (Part I) will be opened first and evaluated to determine responsiveness and completeness to the eligibility criteria. Any clarification / rectification in case of deviations, in the technical bids at this stage, will be called for in writing or by email. Failure to submit the same within the specified time limit may result in rejection of the bid. The Bank will scrutinize the offers and evaluate the Technical Bids based on the eligibility criteria given in Section IV. The Bidders who qualify in Technical Evaluation will be shortlisted for Financial (Price Bid) Evaluation. The decision of the Bank in this regard shall be final and binding on the tenderers.
- b) The Technical Committee formed for the evaluation of the bids / proposals will take into account the eligibility criteria stipulated in the tender. Part II of only those tenderers, who are found to be satisfying the eligibility criteria, will be considered for opening.
- c) The Bank may obtain reports on past performance of the tenderer from their clients. The Bank may evaluate the said reports before opening of the Part II of the tender. If any tenderer is not found to possess the required eligibility for participating in the tendering process at any point of time and / or his performance/ service reports received from his clients are found unsatisfactory, the Bank reserves the right to reject his / her offer after the technical evaluation has been completed. The Bank is not bound to assign any reason for doing so. After the technical evaluation has been completed, the financial /price bids of only technically qualified vendors will then be opened.

#### II. Financial Evaluation:

- a) Opening of Part II will be intimated to the qualified/ eligible vendors. The tender shall remain valid for 90 days from the date of opening of Part I of the tender.
- b) The Bank will open and scrutinize the financial offers of the technically qualified bidders only. The Financial Bids will have to be uploaded online as per the illustrative format in Part II. Financial Bids should not have any alteration or overwriting. The Bank may reject the financial bid or load the financial implication on the respective Bidder for any alteration, if found in the Financial Bid submitted by the respective Bidder.



#### | Final Evaluation (Offline process):

The tenderer who qualifies the Technical Evaluation and is H1 in Financial Bid shall be awarded the tender. H1 tenderer will be decided on the basis of Highest Uniform Discount on the Printed Retail Price offered on all items of Supply to the Bank's beneficiaries.

#### D Pre-bid meeting:

A pre-bid meeting will be held on **August 22, 2025 at 10.30 a.m.** at Main Office Premises of Reserve Bank of India, Bhubaneswar to discuss/clarify any queries about the tender. All the intending tenderers are advised to attend the meeting. Not more than two authorized representatives of any tenderer can attend the pre-bid meeting with prior intimation to the Bank. Minutes of the meeting/clarifications, if any, will be uploaded as corrigendum to the tender in MSTC portal and also RBI website, **on August 22, 2025**. **Bidders are advised to see corrigendum, if any, before submitting their bids.** 



#### **SECTION V**

#### 2. TERMS AND CONDITIONS

#### I. Scope of Work

- a) The Bank will enter into a contract with vendor who offers the highest uniform discount. The vendor will supply the medicines at the agreed discount in the stipulated time and at the specified place based on the indents issued from time to time by the Bank. It may be noted that the Bank is not bound to procure all its requirements of medicines only from the vendor offering the highest discount.
- b) The Bank also reserves the right to split/ divide its purchases among two or more vendors/ bidders. The Bank also reserves the right to accept any or reject any or all the offers that it may receive without giving any reasons.
- c) The successful bidder will enter into a Contract Agreement with the Bank as per the format in Annex VII. The contract will be valid for the period September 16, 2025 to March 31, 2026 and the uniform discount quoted by the vendor/ bidder shall remain firm and valid for the period.
- d) All the vendors may please note that any amendments/ corrigendum to the RFQ, if issued in future, will be notified on the RBI Website and MSTC Website as given above and will not be published in the newspaper.
- e) The Bank has four dispensaries within the municipal area of Bhubaneswar city (details given in Annex VIII). Out of these four dispensaries, two are functional at present to which the successful bidder needs to supply medicines. The estimated procurement value has been arrived at considering supply of medicines to these two functional dispensaries. However, in case the remaining dispensaries get functional during the contract period, the successful bidder needs to mandatorily supply medicines to all the four dispensaries. Accordingly, the estimated contract amount may vary.

#### **II.Indent and Delivery of Supplies**

#### a) Delivery of Supplies:

On receipt of indent for supply from the Bank, the delivery of supplies in full shall be made to the dispensaries of the Bank to which the indent pertains, during the working hours of the dispensary as soon as possible but not later than five working days (including Saturday) from the date of receipt of the indent.

#### b) Non-substitution/ confirmation with Schedule M:

In case of indent for specific brands of medicines, the brand shall not be substituted. In other cases, medicines which are confirming to Schedule M specifications of the Central Drug Standard Control Organization shall be supplied.

#### c) Packed Supplies:

Supplies are required to be made in original packing of manufacturer. Original packing of manufacturer should approximately be nearest to the total quantity indented of any particular medicine/ drug.



#### d) Authority Slip:

In case an Authorized Official of the Bank or the Bank's Medical Consultant of the dispensary concerned gives any 'By Hand' Authority Slip to a beneficiary, the medicines shall be supplied immediately to the beneficiary for a period as mentioned in the slip.

#### e) Life period of medicines supplied:

Every medicine has its own shelf-life period mentioned on the label of medicines. The shelf life of medicines supplied should not have passed more than half of its shelf life at the time of supply or medicines supplied should have a minimum of 1.5 years shelf-life whichever is higher.

#### f) Expiry of medicines:

The chemist shall make arrangement to replace the near expiry medicines i.e., medicines with expiry of six months (06) and less with medicines of greater expiry date i.e., at least one year or half of its own shelf-life period at the time of supply, whichever is higher.

#### g) Notice period:

The chemist should not stop the supplies of the medicines without giving Ninety (90) days' notice. However, during the notice period, the Chemist shall arrange to continue to supply the medicines.

#### h) Indent:

The chemist will indicate batch number, name of manufacturer, date of expiry in the indents at the time of supplying the medicines/drugs to the Bank's dispensary.

#### i) Supply of medicines:

Sufficient stock of standard quality of medicines at all times will have to be maintained by the chemist, to avoid inconvenience to the Bank's beneficiaries. The chemist should agree to supply all the medicines and consumables that the Bank indents irrespective of the brands or manufacturers. Failure to do so after execution of the purchase contract as described elsewhere in the document will result in forfeiture / invocation of Security deposit / Performance Bank Guarantee.

#### III.Pricing:

In response to the Bank's purchase order:

- a) The chemist should quote uniform discount on retail price printed on Strip/Bottle/Unit packed (in percentage term) in respect of all items of supplies to be made under the Contract irrespective of their brands or manufacturers.
- **b)** The liability to pay any duties, levies or taxes leviable under the law would be that of the chemist.
- c) The chemist will also have to bear all the expenses connected with proper packaging, carting, shipping, transportation etc. in connection with supply of medicines to any place specified by the Bank.
- **d)** The Bank will only pay the labelled MRP less discount allowed thereon after deducting applicable taxes. The quoted offer shall remain valid for the entire



duration of the contract. Under no circumstance will a request for alteration in the discount rate will be accepted/ considered.

#### IV. Presentation and payment of bills:

- a. The chemist shall present the bill to Medical Section, HRMD, RBI, Bhubaneswar. The bill should clearly indicate the details of the supplies made such as name of the medicine, quantity, MRP, discount amount with percent figure, batch No., expiry date, HSN code, GST amount, bill date, etc. and any other information required by the Bank. The bill should be supported with necessary documents, including proof of delivery, in physical or electronic form.
- b. The bill shall be supported by the original indent along with the certificate from the authorized official of the Bank in charge of the dispensary under his/her signature, with date, seal of the office for receipt of the items indented. Each bill should carry the signature of the proprietor or the authorised representative with the stamp of firm/ company.
- c. Incomplete bills not accompanied by any of the particulars mentioned in (a) & (b) above or erroneous bills will not be entertained, and the Bank shall bear no responsibility in this regard.
- d. The authorized chemist shall claim payments within 10 working days of supply of items. The chemist shall present bill individual dispensary wise for all indents, which have been delivered and completed. Payments of the bills presented will normally be arranged in 30 working days from the date of presentation of the correct bill. However, the authorized chemist shall make no claim from the Bank in respect of interest or damages in case the payment is delayed for any reasons.
- e. The Bank would be deducting TDS on GST and IT-TDS (wherever applicable) and paying to the Government of India. Hence, individual HSN wise taxable value along with their GST rate should also be submitted by the chemist along with the bill.
- f. The payment will be made through NEFT / RTGS for which chemist should give requisite details such as bank account number, IFSC code, bank branch details, etc.
- g. The chemist must ensure timely filling of GST return in GSTR-1 portal. The data uploaded in the GSTR-1 should invariably tally with the amount mentioned in the invoices raised to the Bank. The chemist will issue Credit/ Debit note to the Bank, in case of modification of already generated invoices or mismatch of GSTR -1 filling data and actual invoice data. The chemist shall intimate the Bank on filing of monthly GST Return, whenever called for by the Bank.
- h. It may be noted that the Bank is not bound to procure all its requirements of medicines only from the chemist offering the highest discount. The Bank also reserves the right to split/ divide its purchases among two or more vendors. The Bank also reserves the right to accept any or reject any or all of the offers that it may receive without giving any reasons thereof.



It is not the intent to specify completely herein all details of work covered under this enquiry. Scope of work may also include such other related works although they may not be specifically mentioned in the above paragraphs and all such incidental items of works not specified but reasonably implied and necessary for completion of the job as a whole.

#### 3. SPECIAL CONDITIONS:

#### 1. Corrupt, fraudulent or unethical practices:

The Bank requires that the chemist observes the highest standards of ethics during the procurement and execution of contract for supply of medicines. The medicine to be supplied will be of standard quality. In pursuance thereof, the terms are set forth as follows

- a) The chemist shall not resort to offering, giving, receiving or soliciting of anything of value to influence the action of any official of the Bank in the tendering process or in contract execution.
- b) The chemist shall not resort to misrepresentation of facts in order to influence the tendering process or execution of a contract to the detriment of the Bank.
- c) The Bank will declare a chemist ineligible, either indefinitely or for a specified period of time, for award of the contract, if at any time, it determines that the chemist has engaged in corrupt and fraudulent practices in executing the contract.
- d) The Bank reserves the right to terminate the contract with immediate effect for non-fulfilment of the terms and conditions of this tender by the chemist. The Bank may, without prejudice to any other remedy for breach of contract, at its sole discretion, terminate the contract in whole or part in respect of any chemist for any of the following reasons:
  - i. If the chemist fails to provide any or all of the services within the period(s) specified in the Contract.
  - ii. If the chemist fails to perform any other obligation(s) under the Contract.
  - iii. If the vendor, in the judgment of the Bank has engaged in corrupt or fraudulent practices in competing for or in executing the Contract.
  - iv. Supply of sub-standard/ spurious/ substitute medicines/expired medicines.
  - v. Delay in supply/ refusal to supply/ non-supply of medicines.
  - vi. Overcharging in the bill.
  - vii. If the chemist, being an individual, dies, the Bank shall have the option of terminating the contract without any liability for such termination and compensation to the Vendor.
- e) If any such case indicated in (d) above is noticed during subsequent scrutiny after or before the payment, then the chemist shall refund the disputed/excess amount already paid by the Bank, replace the medicine in question. The Bank may stop payments due or recover the cost of such supplies from the amounts due to the chemist.

#### II. Applicability of best prices:



If the chemist with whom the Bank has entered into purchase contract offers a higher discount or sells or even offers to sell medicines following conditions of sale similar to those of the Bank's contract, to any person or organization during the currency of the rate contract, the discount rate applicable to the Bank will be automatically increased with effect from that date for all the subsequent supplies under the contract and the contract be amended accordingly. Other parallel contract holders, if any, will be given opportunity to reduce their price as well, by notifying the reduced price to them and giving them 15 (fifteen) days' time to intimate their revised prices, if they so desire, in sealed cover to be opened in public on the specified date and time and further action taken as per standard practice.

#### III. Deduction for delay/ default

- a) In case of indent for specific brand of medicines, the same shall not be substituted without due approval of the Bank's Medical Consultants. If any such case is noticed during subsequent scrutiny after or before making the payment, then chemist will be **penalized** for ₹1,000 + cost of the specific brand of medicines for each such default.
- **b)** The delivery of supplies in full shall be made to the dispensary to which the indent pertains within the next five (05) working days (including Saturday) or at the resident of the patients in case of emergency, as directed by the Bank.
- c) In the event of non-supply of indented medicines in time as aforesaid, ₹1,000/- will be deducted from the bill of the chemist for each day or part thereof of delay in respect of each item.

#### IV. Termination for default.

The Bank may, without prejudice to any other remedy for breach of contract, at its sole discretion, terminate the contract in whole or part in respect of any chemist for any of the following reasons:

- a) Supply of sub-standard/ spurious/ substitute medicines
- b) Delay in supply/ refusal to supply/ non-supply of medicines
- c) Overcharging in the bill
- d) In case it is found that any particular medicine's date is expired or is near the date of expiry
- e) If the chemist fails to perform any other obligation(s) under the contract
- f) If in the judgment of the Bank, the chemist has engaged in corrupt or fraudulent practices

#### V. Performance Security

The amount of Security Deposit / Performance Bank Guarantee shall be liable to be forfeited/ invoked under the following conditions:

- a) In case of non-commencement of work
- b) In case of non-performance of contract obligations or failure to comply with any of the conditions of the contract, over charging or delivery with substantial delays beyond the prescribed period.



- c) If the medicines supplied by the authorized chemist against the Supply Order placed on them in pursuance of this contract are subsequently found as having been stolen, sub-standard, spurious medicines or substitute medicines or not conforming to quality.
- d) Non-adherence to offered discount
- e) Discrepancies in billing

#### VI. Reservation of right for appointment of more chemists:

The Regional Director, Reserve Bank of India, Bhubaneswar reserves the right to enter into contracts with any number of chemists. The Regional Director, Reserve Bank of India, Bhubaneswar also reserves the right to allocate, reallocate the dispensaries, existing and new ones that may be set up during the Currency of the contract. The Regional Director, Reserve Bank of India, Bhubaneswar also reserves the right to decide which supplier shall normally serve which dispensary. Without prejudice to the right, emergency purchases can be preferred from any chemist irrespective of such allotment of dispensary to each Authorized Chemist for purchase of normal supplies.

#### 4. GENERAL TERMS AND CONDITIONS:

#### a) Registration:

Entities which are eligible, as per the eligibility criteria stipulated at Section IV of the tender document, are entitled to participate in the Tender. The interested tenderers must register on the MSTC portal: <a href="www.mstcecommerce.com/eprocn">www.mstcecommerce.com/eprocn</a> for participating in e-tendering.

#### b) Invitation for Proposal:

This tender document is neither an offer letter nor a legal contract, but an invitation for the proposal. No contractual obligation on behalf of the Bank whatsoever shall arise from this tender-process unless and until a formal contract is signed and executed by duly authorized Officers of the Bank and the tenderer. Further, the Bank will not be held liable for any costs incurred by the tenderer in the preparation of the response to this tender. The preparation of tenderer's proposal will be made without any obligation by the Bank to acquire any of the items included or rejected. All information included by the vendors in their proposal will be treated in strict confidence.

#### c) Payment of Bills:

Purchase order for delivery of medicines to the dispensaries shall be placed by the Bank on quarterly basis. Supplementary ident may also be placed as and when required by the Bank. The authorized chemist shall claim payments within 10 working days of supply of items. Payments of the bills presented will normally be arranged within 30 working days from the date of proper presentation of the bill and also from the date of receipt from the concerned dispensaries, whichever is later. However, the authorized chemist shall make no claim from the Bank in respect of interest or damages in case the payment is delayed for any reasons. The payment shall be made through NEFT/RTGS for which



bidder should give requisite details such as bank account number, IFSC code, bank branch details, etc.

#### d) Period of Contract:

- i. The contract will be valid for the period September 16, 2025 to March 31, 2026. The Bank reserves the right to terminate / end the contract at any time during the period the contract with the bidder by giving a notice of 30 days in advance. The Bank is not bound to specify any reason while issuing the 30 days' notice.
- ii. In respect of the purchase contract, supply orders will be placed against the contract up to the last date of the contract. Orders received even on the closing date should be honoured in accordance with the terms of contract even though the last date of the contract may have expired on the date of supply of medicines.
- iii. The Bank also reserves the right to extend the validity of the existing contract for the period as per the requirement of the Bank or one year at a time and at the same discount rate subject to satisfactory performance of the bidders. The bidders need to submit the revised Performance Bank Guarantee (PBG)/ Security Deposit (SD) with extended validity and fresh Contract, in case the validity is extended by the Bank. In no case, the contract period will be extended beyond three years in total.
- iv. The period of contract may be considered for extension by the Bank subject to the satisfactory performance of supplier and Bank's administrative convenience and requirements.
- v. The supplier should not stop the supplies of the medicines/ drugs without giving 90 days' advance notice to the bank.
- vi. The Bank reserves the right to terminate the contract immediately and delist the suppliers from the supply of the drugs and medicines if services of the suppliers are found unsatisfactory. However, before terminating/delisting such supplier, the Bank shall give notice and consider the reply, if any, given by the supplier.

#### e) Acceptance of terms and conditions:

The tenderer must convey its acceptance of all terms & conditions in form of tender (Section VI of the tender) duly signed by the authorized signatory and upload the same along with Part I documents.

f) The Bank reserves the right to accept any or reject any or all of the offers that it may receive without assigning any reasons.

#### g) Submission of Tender:

- i. Tenders shall be submitted in two parts viz. Part I containing Eligibility Criteria and technical details of the offer and Part II containing **prices only.**
- ii. Part I documents should contain the information / documents, as indicated in <u>Annex</u> <u>I which should not contain any information on price for</u> the proposed work, to be uploaded on MSTC portal.



#### h) Right to accept / reject any or all applications:

Applications received after the due date and time or incomplete in any respect are liable to be rejected. The Bank reserves the right to accept or reject any or all the applications in full or part without assigning any reason thereof. The Bank reserves the right to scrap the panel at any time, without assigning any reason thereof. The Bank's decision in this regard shall be binding and final. The Regional Director, Reserve Bank of India, Bhubaneswar has the right to modify / alter any requirements in this document at his discretion in the interest of the Bank as deemed appropriate to him. The decision of the Bank / Regional Director in this regard shall be final.

#### 5. Supply of medicines, medical, non-medical, surgical and non-surgical items etc.:

- a) Sufficient stock of standard quality of medicines at all times will have to be maintained by the chemist, to avoid inconvenience to the Bank's beneficiaries.
- b) In case of failure or refusal on chemist's part to supply the medicines, medical & non-medical, surgical & non-surgical items etc. to the purchaser / beneficiaries within the time as provided in the respective PO, the contract is liable to be terminated / cancelled at chemist's risk and cost. Any extra cost involved in arranging supply from alternative source will be recovered from the chemist. It is in addition and without prejudice to the deduction in clause 3 (III) above and (e) below.
- c) The chemist shall clearly indicate the details of the supplies made such as name of the item, quantity, MRP, discount amount, batch No., expiry date, taxable and GST amount, HSN code, bill date etc. and any other information required by the Bank, in the bill at the time of supplying the medicines/drugs to the concerned dispensaries.
- d) The medicines, medical, non-medical, surgical & non-surgical items etc. to be supplied will be of standard quality. In case it is found that any particular medicine has reached its expiry date or is near expiry, found not of standard quality, substandard or spurious, chemist's (Appointed Authorized Chemist) firm will be liable to be debarred for a period of 3 years besides other legal action that may be initiated. In case the chemist fails to supply indented medicines, medical & non-medical, surgical & non-surgical items etc., the Bank will be entitled to procure the same from another vendor and the chemist will be liable to reimburse the full price paid by the Bank. However, the chemist will be allowed to claim from the Bank, only as per the agreed terms & conditions for those items.
- e) In case of indent for specific brand of medicines, the same shall not be substituted. If any such case is noticed during subsequent scrutiny after or before the payment, then chemist will be penalized for ₹1,000/- + cost of the specific brand of medicines for each such default.

#### 6. INDEMNITY/ INSURANCE CLAUSE:

i) The chemist shall indemnify the Bank against all actions, suits, claims and demands brought or made against the Bank in respect of anything done or committed to be done by the chemist in execution of or in connection with the work of this contract and due to non-adherence to the terms and conditions as stipulated therein in this document or contract for this purpose and against any loss or damage to the Bank in consequence to any action or suit being brought against the chemist for anything done or committed to be done in the execution of this contract.



- ii) The bidder / Chemist shall abide by the job safety measures prevalent in India and shall free the Bank from all demands or responsibilities arising from accidents or loss of life, the cause of which is the bidder's / chemist's negligence. The bidder / chemist shall pay all indemnities arising from such incidents without any extra cost to the Bank and will not hold the Bank responsible or obligated.
- iii) In case any employee of the chemist so deployed enters in a dispute of any nature whatsoever, it will be the primary responsibility of the chemist to settle/contest the same. In case the Bank is made party and is supposed to contest the case, the Bank will be reimbursed for the actual expenses incurred towards Counsel fee and other expenses, which shall be paid in advance by the chemist to the Bank on demand. Further, the chemist shall ensure that no financial or any other liability comes on the Bank in this respect of any nature whatsoever and <a href="mailto:shall-keep the Bank">shall-keep the Bank</a> indemnified in this respect.
- iv) The successful bidder/s shall take "contractor all risk policy" for the contract value at his own cost in the joint name of Reserve Bank of India, Bhubaneswar and the successful bidder with Reserve Bank of India, Bhubaneswar's name being placed first in the policy.
- v) The policy shall be valid for the contract period and shall be renewed by the successful bidder at his own cost if the contract is renewed by the Bank.
- vi) The insurance policy shall be submitted by the successful bidder/s within 10 days of award of work or before commencement of the work, whichever is earlier.
- vii) On failure to procure such a policy, the Bank reserves the right to take the above insurance policies and recover the cost thereof from the bill of the successful bidder.
- viii) The successful bidder/s shall be responsible for any liability which may not be covered by the above insurance policy and also for all other damages to any person, animal, or defective carrying out of this contract, whatsoever may be the reasons due to which the damage shall have been caused.

#### 7. ARBITRATION:

The contract is based on mutual trust and confidence. Both the parties agree to carry out the assignment in good faith. If any dispute or difference of any kind whatsoever (the decision whereof is not herein otherwise provided for) shall arise between the Bank and the Bidder in connection with or arising out of the Contract, whether during the contract period or completion and whether before or after the termination, abandonment or breach of the contract, shall be referred to and settled by sole arbitration by the Regional Director, Reserve Bank of India, Bhubaneswar who shall give written award of his decision to the Bidder. The decision of the Regional Director will be final and binding.



# 8. All legal suits, actions or proceedings relating to or arising out of the agreement / contract shall be subject to jurisdiction of courts/tribunals at Bhubaneswar only.

#### 9. Non-Disclosure Clause:

The contractor / chemist shall not disclose directly or indirectly any information, materials and details of the Banks, infrastructures/ systems/ equipment etc. which may come to the possession or knowledge of the contractor during the course of discharging its contractual obligations in connection with this agreement, to any third party and shall at all times, hold the same in strictest confidence. The contractor / chemist shall treat the details of the contract as private and confidential, except to the extent necessary to carry out the obligations under it to comply with applicable laws. The contractor / chemist shall not publish, permit to be published, or disclose any particulars of the works in any trade or technical paper to elsewhere without the previous written consent of the Bank. The contractor / chemist shall indemnify the bank for any loss suffered by the Bank as a result of disclosure of any confidential information by the contractor / chemist or its employees / agents. Failure to observe the above shall be treated as breach of contract on the part of the contractor / chemist and the Bank shall be entitled to claim damages and pursue legal remedies. The contractor / chemist shall take all appropriate action with respect to its employees / agents to ensure that the obligation of non- disclosure of confidential information under the agreement are fully satisfied.

#### Sexual Harassment of women at workplace (Prevention, Prohibition and Redressal) Act, 2013:

- a) The vendor/ chemist shall be solely responsible for full compliance with the provisions of "The Sexual Harassment of Women at workplace (Prevention, Prohibition and Redressal) Act 2013". The vendor/ chemist shall ensure appropriate action under the said act in respect of the complaint.
- b) Any complaint of sexual harassment from any aggrieved employee of the vendor/ chemist against any employee of the Bank shall be taken cognizance of by the Internal Complaints Committee constituted by the Bank.
- c) The vendor/ chemist shall be responsible for any monetary compensation that may need to be paid in case the incident involves the employees or agents or supply men of the contractor, for instance any monetary relief to Bank's employee, if sexual violence by the employee of the contractor is proved.
- d) The vendor/ chemist shall be responsible for educating its employees or agents or supply men about prevention of sexual harassment at workplace and related issues.
- e) The vendor/ chemist shall provide a complete and updated list of its employees or agents or supply men who are deployed for the purposes of the contract within the Bank's premises.



The contractor/agency shall ensure appropriate action under the said Act in respect of the complaint.

The Contractor shall indemnify the Bank for any loss suffered by the Bank because of disclosure of any confidential information. Failure to observe the above shall be treated as breach of contract on the part of the Contractor and the Bank shall be entitled to claim damages and pursue legal remedies. The Contractor shall take all appropriate actions with respect to its employees to ensure that the obligations of nondisclosure of confidential information under this agreement are fully satisfied.
