i.	Whether MSME bidders are exempted from remitting EMD for this tender?	No.
ii.	Please clarify if the car count requirement applies per category or to the entire fleet.	Kindly refer to Clause 1.16 (iii) of Section II of "General Instructions regarding technical and financial bids" (page no.18-19) of the tender document for details.



iii.	Will the final billing include charges for both extra kms and extra hours?	Kindly refer to Clause 9 of Part II of "Price Bid" (page no.67) of the tender document for details.
iv.	Does the billing calculation include the garage-to-garage distance and time?	Kindly refer to Clause 4 of Part II of "Price Bid" (page no.66) of the tender document for details.
v.	Is the contractor required to provide both Performance Bank Guarantee and Retention Money Deposit?	Kindly refer to Sr No. 7 & 8 of Schedule of Tender page no.6) of the tender document for details. Successful tender shall submit Performance Bank Guarantee 5% of the estimated cost and Retention Money Deposit 5% of the estimated cost as per RBI, CO policy.
vi.	Can Bidders submit old Banker's certificate?	Bankers Certificate should be submitted specifically in the format provided by the Bank (Annex-B).
vii.	Is ISO-9001 compulsory for applying tender?	ISO-9001 certificate is not compulsory requirement however it may be submitted by the bidders if available.
viii.	Will agreed rates will be reviewed at the time renewal of contract?	Kindly refer to Clause 13 of Section IV of "Scope of work and Terms & Conditions governing the Contract" (page no.43) of the tender document for details.
ix.	Is there any format for providing bankers' details?	Details of Bankers should be submitted as per format in <a href="#">Annex I</a> appended below.
x.	Can bidders submit Client Certificate in any other format than mentioned in Tender?	Client certificate should be submitted preferably in the format provided by the Bank (Annex-C). Any other format may be accepted provided it fully covers all the aspects and parameters mentioned in the Bank's prescribed format.
xi.	Will client certificates obtained from other Regional Offices of RBI be considered separately?	Client certificates provided other Regional Offices of RBI will be considered separately.
