2.	Which locations are serviceable?	The serviceable locations have been mentioned in para 4.1 od the RFQ. Bank reserves right to add or remove serviceable locations.
3.	What is the format of data provided for printing of RFID Tags?	The format of data for printing RFID tags would be provided in Excel sheet with following fields:  1. Asset Inventory Number 2. Asset Description 3. Asset Location 4. Asset Purchase Date 5. Asset Tag Type i.e (Electronic, Metallic or Non-Metallic)
4	Should the report of pre-2009 assets be separate?	If the assets of pre-2009 bear any RFID tags then list of such assets may be provided in a consolidated manner in the half-year physical verification and reconciliation report.
5	Can the liquidated damages start period be extended to 20 days from current 15 days for delay in supply of the RFID tags and fixing these tags on the assets?	The specific requirement of supply and fixing of RFID tags on assets within 15 days of placing the request for tags has been provided by IT Cell, DoS and hence cannot be extended.
