Commercial & General Conditions

Sealed tenders are invited for Design, Fabrication, Supply, Installation, Testing & Commissioning of electrical power supply panel and allied works in Cash Department at the Bank's Main Office Building in Chandigarh. The tenders shall be submitted in sealed envelope addressed to The Regional Director, Reserve Bank of India, Estate Department, Main Office Building, Central Vista, Sector 17A, Chandigarh- 160017, so as to reach to the Bank not later than 10:30 AM on April 22, 2025. Tenders will be opened on the same day at 11:00 AM. The envelope shall be super-scribed "Design, Fabrication, Supply, Installation, Testing & Commissioning of electrical power supply panel and allied works in Cash Department at the Bank's Main Office Building in Chandigarh". Tenderers are advised to use only the forms supplied by the Bank and not to use any other forms on their own letterhead or otherwise for furnishing any information/rates/amount etc. All the information called for shall be complete in all respects. Information furnished on sheets other than those supplied will not be considered. Incomplete tender or tenders not complying with the requirement will be liable for rejection. Each page of the forms shall be signed and returned.

- 1.2 The work is estimated to cost ₹4.95 lakh (including GST) and is to be completed within 45 days from the 10th day of issue of work order.
- 1.3 The tenderers are advised to submit the tender strictly based on the General Conditions of the Contract and Technical Specifications contained in the tender documents and not to stipulate any deviations.
- 1.4. Eligibility Criteria: This is a limited tender. Only the firms already found eligible by the Bank can participate in the tendering process.

- 1.5. i. The applicants/tenderers have to submit the tender physically before the last date of submission of part-I.
 - ii. The Part-I and Part-II will be opened on the dates as mentioned in the tender. The Bank reserves the right to accept or reject any or all e-Tenders without assigning any reasons thereof.
 - iii. The Bank is not bound to accept the lowest tender and reserves the right to accept either in full or in part any tender and reserves the right to reject all the tenders without assigning any reason there for.
 - iv. Bank reserves the right to accept or reject any or all Bids without assigning any reasons and also reserves the right to relax any of the terms and conditions. No Contractor shall have any cause of action or claim against the Bank for rejection of his Bid.
 - v. Applicants intending to apply will have to satisfy the Bank by furnishing documentary evidence in support of their possessing required eligibility and in the event of their failure to do so, the Bank reserves the right to reject their candidature. vii. All the tenderers may please note that any amendments / corrigendum to the tender, if any, issued in future will be notified on the Bank's Website and via email.
 - 1.6 A pre-tender briefing meeting cum site visit for the intending tenderers will be held offline at 12:00 hours on April 18, 2025, to clarify any point / doubt raised by them in respect of the tender. No separate communication will be sent for this meeting. All the intending tenderers are advised to study the tender document and to be present in the above meeting. These issues will be discussed, and all the tenderers will be advised suitably. The pre-bid meeting shall be followed by a visit to the site. The tenderers are expected to get all the issues clarified during the above meeting and should desist from deviating from the Bank's tender conditions/specifications in their tender (Part–I and Part–II).
 - 1.7 All information, correspondence letters shall be submitted and addressed to the Regional Director, Reserve Bank of India, Estate Department, Chandigarh.

2.0 Submission of Tender

The tenderer shall upload the necessary documents as specified in the technical and commercial clause of the tender document before the due date of submission.

3.0 Part I – Technical & Commercial

- 3.1 Part I This part shall contain the unpriced tender consisting of complete technical specification including drawings and documents and commercial terms and conditions technical aspects of the tender such as equipment data sheets, tests and inspection, makes of materials, technical description, drawings.
- 3.2 Part I of the tender as submitted shall also contain the following:
 - a) Power of Attorney / authorization with the seal of the company/firm in the name of the person signing the tender documents.
- 3.3 The Tenderers are advised to visit the site of installation and acquaint themselves of the site conditions before tendering.
- 3.4 The tenderers are advised to submit the tender based strictly on the General Conditions of the Contract and Technical Specifications contained in the tender documents, and not to stipulate any deviations. If acceptance of the terms and conditions given in the tender documents has any price implications, the same should be considered and included in the quoted price.

4.0 Part II - Price:

- (a) This part shall contain prices in Indian Rupees only as per format (Part II). No other enclosure is permitted in Part II. Tender in which prices are quoted in any other currency will not be considered.
- (b) No request for any change in rate or conditions after the opening of the tender will be entertained.
- (c) This contract is neither a fixed lump sum contract nor a piece work contract but is a contract to carry out the work in respect of to be paid for according to actual measured quantities for Design, Fabrication, Supply, Installation, Testing & Commissioning of electrical power supply panel and allied works in Cash Department at the Bank's Main Office Building in Chandigarh at the rates/quantities provided in the schedule of rates (Part II).

(d) The rates quoted shall be deemed to be for the finished work and shall be firm and binding without any escalation whatsoever till the system is handed over to the Bank.

5.0 Opening of Tender:

5.1 Part I and Part II of the tenders will be opened on **April 22, 2025 at 11:00 hrs.** in the presence of tenderers who choose to remain present. The tenderers are advised to remain present during the opening of Part I and Part II of the tenders.

6.0 Brief Scope of Work:

- 6.1 The scope of work shall include the following:-
- Design, fabrication, supply & delivery of electrical panel and all components, equipment and material for the captioned work to the Bank's site at Chandigarh including insurance, packing, handling, transporting, clearing, loading/ unloading at ports in India and unloading at site in Chandigarh.
- Installation, testing & commissioning of electrical panel with allied works such as cabling and panel relocation etc. as per technical specifications and handing over the same to Bank.
- All engineering, equipment, labour, and permits required to satisfactorily complete the above works as required by this Specification.
- Any other work, related to but not mentioned above, required for completion of the job shall be included in the scope of this contractor.
- 6.2 The tenderer should indicate in his tender the complete description of the working of the system /sub systems with all relevant brochures/literature etc. in addition to those called for in the Technical Specifications.
- 6.3 The Tenderer shall carefully check the specifications and shall satisfy himself that the equipment offered is suitable as per the enclosed Technical Specifications and shall take full responsibility for the efficient working of the equipment offered. Tenderer shall supply/ arrange all tools, plants, labour and consumables etc. as required for installation, testing and commissioning of the electrical panel.

7.0 Packing and Dispatch:

7.1 The equipment shall be properly and securely packed in boxes suitable for export (wherever applicable) and multiple handling and transportation by sea/ air / rail / road under Indian conditions. All equipment/components shall be delivered on Duty Delivery Paid (DDP) basis at the Bank's site (Main Office Building) at Chandigarh.

8.0 Taxes and subsidies:

8.1 The prices quoted for the work shall include GST and other applicable taxes or any other taxes/duties imposed by Central /State Government/ Local Bodies, charges for labour, transport, insurance charges etc till the work is finally handed over to the Bank. If the Bank is required to discharge the liability of any taxes on the transaction like TDS(IT), TDS(GST), Service Tax under reverse mechanism or any other similar taxes, which is or becomes payable by the Bank, the same shall be deducted from the bills of the contractor. If the Tenderer fails to include such taxes and duties in the tender, no claim thereof will be entertained by the Bank afterwards. As per Indian laws, income tax and works contract tax/GST etc. whatever applicable will be deducted at source.

8.2The rates quoted for the work of DSITC of the electrical panel & allied works shall be firm till handing over of all the systems. No claim in respect of any statutory variations in the existing tax/duties/ imposition of new tax etc. shall be entertained during execution of the work.

9.0 Validity of Tender:

9.1 The Tender along with the prices shall remain valid initially for a period of 90 days from the date of opening of tender, which period may be further extended by mutual agreement in writing by the Tenderer and the Tenderer shall not cancel or withdraw the tender during this period.

10.0 Language:

10.1 The Tender including all labels in drawings, documents, catalogues etc. shall be in English or Hindi

11.0 Lowest Tender Not Necessarily to Be Accepted:

- 12.1 The Bank is not bound to accept the lowest /any tender or to assign any reason for non-acceptance.
- 12.2 The tenderer whose tender is not accepted shall not be entitled to claim any costs, charges, damages and expenses of and incidental to or incurred by him through or in connection with his submission of tenders, even though the Bank may elect to modify/withdraw the tender.

12.0 Right to Accept Part Tender:

12.1 The Bank reserves the right to accept the tender either in whole or in part at the prices quoted by the Tenderer.

13.0 Evaluation of Tender:

13.1 The tenders will be evaluated based on the total cost of work quoted.

14.0 Inspection of materials/work at site

- 14.1 Before dispatching the equipment to site, the equipment may be inspected by the Bank's Engineer-in-Charge of the project at the manufacturers' works and then cleared for shipment. The contractor shall offer to the inspector, at contractor's cost all reasonable facilities as may be necessary for inspection and satisfying himself, that the equipment is being or have been manufactured in accordance with specifications laid down in the particular specifications attached to this tender document. All the expenditure for Bank's engineer visit and stay shall be borne by the Bank. The Bank's engineer shall inspect the materials at site also after delivery before the same is used in the work.
- 14.2 The Bank's engineer shall have free and full access at any time during execution of the contract to the contractor's works or site in case of the execution of work for the aforesaid purpose, and he may require the contractor to make arrangements for inspection of work or any part thereof or any material at his premises or at any other place specified by the Bank's Engineer and if the contractor

has been permitted to employ the service of a sub-contractor, reserve to the Bank's Engineer a similar right.

- 14.3 The above will, however, not in any way absolve the contractor of his responsibility about proper performance of the system/ components after erection and commissioning at the designated place.
- 14.4 The Bank's Engineer shall have the power
 - a) Before any equipment or part thereof are submitted for inspection to certify that they or any portion thereof are not in accordance with the contract owing to adoption of any unsatisfactory method of manufacture.
 - b) To reject any equipment or parts submitted as not being in accordance with the specification.
 - c) To reject the whole of the equipment tendered for inspection, if after inspection of such portion thereof as he may in his discretion think fit, he is satisfied that the same is unsatisfactory; and
 - d) To mark the rejected equipment or parts with a rejection mark so that it may easily be identified if re-submitted.
- 14.5 <u>Consequence of rejection</u>: If on the equipment or a part thereof, being rejected by the Bank's Engineer, the contractor fails to make satisfactory supplies or rectify the faulty work thus executed within the stipulated period of delivery/completion period, the Bank shall be at liberty to:
 - i) Allow the contractor to re-submit the equipment or parts in replacement of those rejected, within a time to be specified, the contractor bearing the cost of freight if any, on such replacement without being entitled to any extra payments on that account; or
 - ii) Purchase/execute or authorise the purchase/execution of quantity/work of the equipment or parts rejected or others of a similar description (when equipment or parts exactly complying with specifications are not, in the opinion of the Bank which shall be final, readily available) to the contractor at his risk and cost and without affecting the contractor's liability as regards supply under the contract; or

- iii) Cancel the contract and purchase/execute or authorise the purchase/execution of the equipment or others of a similar description (when equipment or parts exactly complying with specifications are not in the opinion of the Bank, which shall be final, readily available) at the risk and cost of the contractor. In the event of action being taken under such clause (ii) above or this clause, the provision of delivery clause applies as far as applicable.
- 14.6 <u>Bank's Engineer's decision as to rejection final</u>: The Bank's Engineer's decision as regards the rejection shall be final (in writing) and binding on the contractor subject to contractor's appeal.

15.0 Completion Period:

- Time allowed for carrying out the work, as mentioned in the Memorandum, shall be strictly observed by the Contractor and it shall be reckoned from the 10th day of issue of written order to commence the work. The work shall throughout the stipulated period of the contract be proceeded with all the due diligence and if the contractor fails to complete the work within the specified period, he shall be liable to pay liquidated damages at the rate of 0.25% of the cost of work executed per week for the period during which the said works shall so remain incomplete subject to a maximum of 10% of the accepted tender amount.
- 15.2 Bank will provide storage space within the compound of the building. However, the responsibility and safety of the materials stored will be with the contractor. No accommodation will be provided for any worker by the Bank.
- Liquidated Damages: The work shall throughout the stipulated period of the contract be preceded with all the diligence and if the contractor fails to complete the work within the specified period, he shall be liable to pay liquidated damages, which is at the rate of 0.25% of the cost of work executed per week for the period during which the said works shall so remain incomplete subject to a maximum of 10% of the accepted tender amount, and the Employer may deduct such damages from any money due to the Contractor.

16.0 Insurance

The contractor shall, before commencement of the works, submit requisite insurance to insure the works at his cost and keep them insured until the virtual completion of reworks, against loss or damage by fire with an office in the joint names of the employer and the contractor (the name of the former i.e. RBI being placed first in the policy) for the full amount of the contract. Such policy shall cover the property of the "Employer" only. The contractor shall deposit the copy of policy and receipts for the premium with the employer preferably within seven days from the date of award of work or before dispatch of material at site, whichever is earlier.

In default of the contractor, insuring as provided above, the employer may so insure the works and may deduct the premium paid from any moneys due, penalty etc., or which may become due to the Contractor without prejudice to the other rights of the Employer in respect of such default.

In case it becomes necessary to suspend the works, the Contractor shall as soon as the claim under the policy is settled, or the work reinstated by the Insurance Office, should they elect to do so, proceed with all due diligence with the completion of the works in same manner as though the fire had not occurred and in all respects under the same conditions of Contract. The Contractor in case of rebuilding or reinstatement after fire shall been titled to such extension of time for completion as deems fit.

The contractor shall take all insurances, namely -

- Contractor's All Risk Policy.
- Workmen compensation policy for the employees of the contractor working at site.
- Third party liability policy for a total of Rs.2.50 lakh and with a limit of Rs. 1 lakh per accident.

17.0 Warranty (Defect Liability Period)

18.1 The entire work, including electrical panel & its components/ sub-assemblies, shall be warrantied for 12 months from the date of completion and handing over to be free from defective workmanship or materials and any defects that may appear within 12 months which in the opinion of the Employer have arisen from

bad workmanship or materials, shall upon intimation by the Employer, be made good by the Contractor within 5 days of the observation without any additional cost to the Bank.

18.2 Penalty for delay in rectification of fault during DLP: There will be a penalty of Rs. 200/- per day subject to maximum of the amount of retention money held by the Bank, if the defect in the system is not rectified within the period of 5 days during the DLP period. Any penalty during the DLP shall be recovered from any dues payable to the contractor or invoke from the security deposit.

18.0 Terms of Payment

The payment for the works to be executed under this contract shall be made as follows:

- a. 95% of the value of work executed on completion of supply, installation, testing & commissioning work.
- b. Balance 5% payment shall be released after completion of 1 year of defect liability period from the date of completion of work.

Retention money of 5% of bill value shall be deducted from each RA bill of the contactor till the total recovery amounts to 5% of contract value as security deposit that shall be returned after successful completion of Defect liability period (of one year).

- 19. The Contractor shall carry out all the work strictly in accordance with drawing, details and instructions of the Bank's engineer. If in the opinion of the Bank's engineer, nominal changes have to be made to suit the site condition and with the prior approval in writing of the Employer, they desire the Contractor to carry out the same, the Contractor shall carry out the same without any extra charge.
- 20. The tenderer must obtain for himself on his own responsibility and at his own expense, all the information which may be necessary for the purpose of making a tender and for entering into a contract and must examine the drawings, inspect the site of the work, and acquaint himself with all local conditions, means of access to the work, nature of the work and all matters pertaining thereto. The Employer's decision in such cases shall be final and shall not be open to arbitration.

- 21. A Schedule of Probable Quantities in respect of each work and Specifications accompany these Special Conditions. The Schedule of Probable Quantities is liable to alteration by omissions, deductions or additions at the discretion of the Employer. Each tender should contain not only the rates but also the value of each item of work entered in a separate column and all the items should be totaled in order to show the aggregate value of the entire tender.
- 22. The contractor shall not be entitled to any compensation for any loss suffered by him on account of delays in commencing or executing the work, whatever the cause of delays may be, including delays arising out of modifications to the work entrusted to him or in any sub-contract connected therewith or delays in awarding contracts for other trades of the project or in commencement or completion of such works. The Employer does not accept liability for any sum besides the tender amount, subject to such variations as are provided for herein.
- 23. The successful tenderer is bound to carry out all items of work necessary for completion of the job even though such items are not included in the quantities and rates. Schedule of instruction in respect of such additional items and their quantities will be issued in writing by the Bank.
- 24. The successful tenderer must co-operate with the other contractors appointed by the Bank so that the work shall proceed smoothly with the least possible delay. He should make his own arrangement for storage and protection of all materials supplied by him.
- 25. The work has to be carried out in occupied premises. Therefore, due care should be taken to avoid inconvenience to the occupants/office working.

26. Prevention of Sexual Harassment of Women:

a) The contractor shall be solely responsible for full compliance with the provisions of "the Sexual Harassment of women at workplace (Prevention, Prohibition and Redressal) Act, 2013". In case of any complaint of sexual harassment against its employee within the premises of the Bank, the complaint will be filed before the Internal Complaints Committee constituted by the contractor/Agency or Local Complaints Committee as the case may be and the contractor Agency shall ensure appropriate action under the said Act in respect of the Complaint.

- b) Any complaint of sexual harassment from any aggrieved employee of the Service Provider against any employee of the Bank or any employee of any other firm working in the Bank shall be taken cognizance of by the Regional Complaints Committee constituted by the Bank.
- c) The contractor shall be responsible for any monetary compensation that may need to be paid in case the incident involves the employees of the contractor, for instance any monetary relief to Bank's employee or other firm's employee, if sexual violence by the employee of the contractor is proved.
- d) The contractor shall be responsible for educating its employees about prevention of sexual harassment at workplace and related issues.
- e) The contractor shall provide a complete and updated list of its employees who are deployed within the Bank's premises.

27. Non – Disclosure clause:

- a) The contractor shall not disclose directly or indirectly any information, materials and details of the Bank's infrastructure/systems/equipment etc., which may come to the possession or knowledge of the Service Provider and /or the DB Developer during the course of discharging their contractual obligations in connection with this agreement, to any third party and shall at all times hold the same in strictest confidence. The contractor shall treat the details of the contract as private and confidential, except to the extent necessary to carry out the obligations under it or comply with applicable laws. The contractor shall not publish, permit to be published, or disclose any particulars of the works in any trade or technical paper or elsewhere without the previous written consent of the Second Party. Failure to observe the above shall be treated as breach of contract on the part of the contractor, as the case may be, and the Second Party shall be entitled to claim damages and pursue legal remedies.
- b) The contractor shall take all appropriate action with respect to its employees to ensure that the obligations of non-disclosure of confidential information under this agreement are fully satisfied.
- c) The obligations of the Service Provider and, without prejudice to the contract Agreement, the obligations of the contractor with respect to non-disclosure and

confidentiality shall survive the expiry or termination of this agreement for whatever reasons

Scope of work

The electric panel shall be factory assembled, floor mounted on new duly painted MS angle frame stand minimum angle size 50 mm X 50 mm X 6 mm, totally enclosed cubicle compartmental type, dead front design. The degree of protection of the enclosure shall be IP 50. The unit shall comprise of pressed CRCA (Cold rolled cold annealed) sheet steel and the thickness of all load bearing members, non-load bearing members, doors and side panels being not less than 1.6 mm. Operating height of devices in the panel shall not be less than 300 mm or beyond 2000 mm. Neoprene/special rubber gaskets shall be provided in all mating metallic joints to make enclosure dust proof. Ventilation openings shall have wire mesh screen to limit the ingress of dust. Minimum four nos. of ventilating fans shall be provided with MCB protection.

Separate bus bar compartment shall be provided for housing three phase and neutral electrolytic grade 400 Amp current rating copper bus bars conforming to IS:5082 and mounted on fiber reinforced plastic support insulators. The temperature rise of bus bars shall be limited to 50° Celsius over an ambient of 50° Celsius while carrying rated current and the bus bar support insulators shall have adequate creepage distance and antitracking properties with bus bars mounted flexibly to enable expansion/ contraction without strain on the insulators. The bus bars shall be insulated with hot shrinkable PVC sleeve and shall be colour coded. The internal control wiring shall be with 1100V grade multi stranded copper conductor PVC insulated (colour coded i.e. red for phase, black for neutral and green for earthing) having minimum size of 1.5 sq.mm for potential circuits and 2.5 Sq mm for current circuits with well ferruled.

There shall be separate compartment for incoming MCCB, metering, busbar, each feeder, and outgoing cable connector to accommodate its switchgears and other accessories stated in the layout. Extra knockouts other than for incoming cable, outgoing cables and control cables of each starter shall be provided in the detachable side/top gland plate for future cables.

Identification labels shall be provided for all control devices and other components. Identification label shall also be provided for each compartment and panel of the switchboard. The labels shall be of durable metal type with lettering etched/engraved in a legible manner and fixed in a readily visible location.

Panel shall be painted with two coats of primer and duly powder coated of approved colour. One set of Danger plates/stickers (in Hindi and English language) and legends shall be provided at incomer and each outgoing and earthing terminal. Four hooks at the top shall be provided for transportation purpose. Panel shall be installed on duly painted MS angle frame with grouting in the ground.

Incoming power supply compartment

The incoming power supply compartment should have one no. of 4 pole 400Amp 36 kA breaking capacity MCCB in open execution mounted on the back side mounting plate in the panel.

Metering compartment

It consists of one no. of panel type ventilation fan of minimum 6" sweep, one no. Digital Multifunction meter (Model A, Class 1.0, without RS485 port), 3 Nos of tape wound 600/5 Amp CT (current transformer), 3 Nos of LED indicating lamp with 2 Amp C series 10 KA capacity SPMCB mounted on din rail. The internal control wiring shall be with 1100V grade multistranded copper conductor PVC FRLS insulated wires (colour coded i.e. red/yellow/ blue for phase, black for neutral and green for earthing) having minimum size of 1.5 sq.mm for potential circuits and 2.5 Sq mm for current circuits with alphabet and numbered ferule.

Connector compartments

Each connector compartment shall consist of two nos. of panel type ventilation fan of minimum 6" sweep and required mounting plate/ channel with adequate nos. of connectors of suitable ratings for termination of cables.

 - set forth in the said conditions, the Contractor shall upon and subject to the said Conditions execute and complete the work shown upon the said Drawings and described in the said Drawings and described in the said Specifications and the Schedule of Quantities.

 This Contract is neither a fixed Lump sum Contract nor a Piece Work Contract but is a Contract to carry out the work in respect of the entire design, supply, installation, testing, commissioning and handing over of "Design, Fabrication, Supply, Installation, Testing & Commissioning of electrical power supply panel in Cash Department at the Bank's Main Office Building in Chandigarh" for ₹ /- to be paid for according to actual measured quantities at the rates contained in the Schedule of Rates and Probable Quantities or as provided in the said conditions

 The Bank reserves to itself the right of altering the Drawings and nature of the work by adding to or omitting any items of work or having portions of the same carried out without prejudice to this contract.

The work shall, throughout the stipulated period of the contract, be preceded with all the diligence and if the contractor fails to complete the work within the specified peri-od, he shall be liable to pay liquidated damages. The recovery of Liquidated Damages shall be 0.25% of the cost of work executed per week (or part thereof) and subject to a maximum 10% of the accepted tender amount and the Employer may deduct such damages from any money due to the Contractor.

Non-Disclosure clause: The Contractor shall not disclose directly or indirectly any information, materials and details of the Bank's infrastructure/systems/equipment

etc., which may come to the possession or knowledge of the Contractor during the course of discharging its contractual obligations in connection with this agreement, to any third party and shall at all times hold the same in strictest confidence. The Contractor shall treat the details of the contract as private and confidential, except to the extent necessary to carry out the obligations under it or to comply with applicable laws. The Contractor shall not publish, permit to be published, or disclose any particulars of the works in any trade or technical paper or elsewhere without the previous written consent of the Employer. The Contractor shall indemnify the Employer for any loss suffered by the Employer as a result of disclosure of any confidential information. Failure to observe the above shall be treated as breach of contract on the part of the Contractor and the Employer shall be entitled to claim damages and pursue legal remedies. The Contractor shall take all appropriate actions with respect to its employees to ensure that the obligations of non-disclosure of confidential information under this agreement are fully satisfied. The Contractor's obligations with respect to non-disclosure and confidentiality will survive even after the expiry or termination of this agreement for whatever reason.

13. यौन उत्पीड़न की रोकथाम संबंधी उपबंध / Prevention of Sexual harassment clause ठेकेदार / एजेंसी कार्य स्थल (रोकथाम, निषेध और निवारण) अधिनियम 2013 में महिलाओं के यौन उत्पीड़न के प्रावधान के पूर्ण अनुपालन के लिए पूरी तरह जिम्मेदार होगी। बैंक के परिसर के भीतर अपने कर्मचारी के खिलाफ यौन उत्पीड़न की किसी भी शिकायत के मामले में ठेकेदार / एजेंसी द्वारा गठित आंतरिक शिकायत समिति के समक्ष शिकायत दर्ज की जाएगी और ठेकेदार/एजेंसी शिकायत के संबंध में उक्त अधिनियम के तहत उचित कार्रवाई सुनिश्चित करेगी। बैंक के किसी भी कर्मचारी के खिलाफ ठेकेदार के किसी भी गंभीर कर्मचारी से यौन उत्पीड़न की किसी भी शिकायत का बैंक द्वारा गठित क्षेत्रीय शिकायत समिति द्वारा संज्ञान लिया जाएगा। यदि ठेकेदार के कर्मचारी द्वारा यौन हिंसा साबित हो जाती है, तो ठेकेदार किसी भी मौद्रिक मुआवजे के लिए जिम्मेदार होगा, जिसे घटना में कर्मचारी शामिल होने की स्थिति में भुगतान करने की आवश्यकता हो सकती है। ठेकेदार अपने कर्मचारी को कार्यस्थल पर यौन उत्पीड़न की रोकथाम और संबंधित मुद्दे के बारे में शिक्षित करने के लिए जिम्मेदार होगा।

The contractor / Agency shall be solely responsible for full compliance with the provision of "the sexual Harassment of women at workplace (Prevention, Prohibition and Redressal) Act 2013". In case of any complaint of sexual harassment against its employee within the premises of Bank, complaint will be filed before the Internal complaint committee constituted by the Contractor / Agency and the Contractor / Agency shall ensure appropriate action under the said Act in respect to the complaint. Any complaint of sexual harassment from any aggravated employee of the contractor against any employee of the Bank shall be taken cognizance of by the Regional Complaints Committee constituted by the Bank. The Contractor shall be responsible for any monetary compensation that

may need to be paid in case the incident involves the employee, if sexual violence by the employee of the contractor is proved. The contractor shall be responsible for educating its employee about prevention of sexual harassment at workplace and related issue.

The Contractor shall indemnify and keep indemnified the RESERVE BANK OF INDIA against:

- i) Any claim arising out of third party loss/ damage to life or property caused by/during execution of the work.
- ii) Any claim arising out of loss/ damage to the workmen engaged by the contractor during execution of the work.
- iii) Any claim due to non-compliance of applicable PF/ Labour laws, ESI, regulations etc.

The contractor shall take necessary insurance covers (i.e. Contractor All Risk Policy, Workmen Compensation Policy, Third Party Liability etc as applicable) with Reserve Bank of India as the first name, at their cost, before commencement of the work.

16. अनुबंध की समाप्ति / Termination of Contract:

Without prejudice to what is contained hereinabove, the Bank shall at its sole and absolute discretion, be entitled to terminate this agreement forthwith without assigning any reason and without payment of any compensation, if in the opinion

of the bank (which shall not be called into question by the contractor and shall be binding on the contractor):-

The contractor commits a breach of any terms and conditions of this agreement.

The contractor is adjudged an insolvent or a compromise is entered by him with his creditors or if distress or execution or other process is levied upon or receiver is appointed of any part of the assets or property of contractor.

For any reason whatsoever, the contractor becomes disentitled in law to perform his obligations under this agreement.

vi. संविदाकर्ता या उसके व्यवसाय के स्वामित्व/साझेदारी या प्रबंधन में इस तरह के बदलाव के लिए बैंक की लिखित पूर्व अनुमति के बिना कोई भिन्नता है। There is any variation in the ownership/partnership or management of the contractor or his business without the prior approval in writing of the Bank to such variation.

17.न्यूनतम वेतन अधिनियम, 1948, वेतन भुगतान अधिनियम, 1936, अनुबंध श्रम (विनियमन और उन्मलन) अधिनियम, 1970 आदि:

Minimum Wages Act, 1948, Payment of Wages Act, 1936, Contract Labour (Regulation and Abolition) Act, 1970 etc.:

ठेकेदार को अपने कर्मियों को न्यूनतम वेतन अधिनियम के तहत निर्धारित प्रचलित दर पर न्यूनतम वेतन का भुगतान करना चाहिए। मुख्य श्रम आयुक्त (केंद्रीय) इस शर्त का किसी भी उल्लंघन पर अनुबंध समाप्त करने के लिए उत्तरदायी होंगे और तदनुसार कार्रवाई की जाएगी। इसके अलावा, मौजूदा नियमों के अनुसार ठेकेदार द्वारा हर महीने प्रति व्यक्ति ESI और PF का भुगतान किया जाना चाहिए और भुगतान किए गए नकद चालान की प्रतियां हर महीने बैंक में जमा की जानी चाहिए।

The Contractor should pay to their personnel a minimum wage at the prevailing rate as fixed under Minimum Wages Act. The Chief Labour Commissioner (Central) any breach of this condition will be liable for termination of the contract and the same would be dealt with accordingly. Besides, ESI and PF per head at the current rate should be paid by the contractor every month as per the existing rules and copies of paid cash challans should be submitted every month to the Bank.

Necessary records in writing for having made these payments and wage slips of employees will be submitted to the Bank at monthly intervals, for its verification. These records will be duly signed/attested by the employees of the contractor in the presence of Bank's Officials.

The employees engaged by the Contractor will be in the employment of the Contractor only and not of the Reserve Bank of India. The contractor shall pay the employer's contribution with regard to provident fund and employees' state insurance fund as per the provisions of the employees' Provident fund and miscellaneous provisions act, 1952 and employees' state insurance act, 1948.

The contractor will be solely responsible for any penalty or claim arising due to dispute between the contractor and its employee/es under any circumstance. If any claim or penalty is legally binding to the Bank due to the dispute between contractor & its employee/es, same shall be recovered from the contractor.

If the contractor is a Partnership or an dividual
