The sale will be subject to the terms and conditions specified in the <a href="Motification F.No.4(2)-W&M/2018">Motification F.No.4(2)-W&M/2018</a> dated March 27, 2018 along with the <a href="Amendment Notification No.F.4(2)-W&M/2018 dated April 05, 2018">Amendment Notification No.F.4(2)-W&M/2018 dated December 23, 2021</a>, issued by Government of India, as amended from time to time. State Governments, Union Territories with legislature, eligible Provident Funds in India, designated Foreign Central Banks and any person or institution specified by the Bank in this regard, can participate on non-competitive basis, the allocation for which will be outside the notified amount. Individuals can also participate on <a href="mailto:non-competitive">non-competitive</a> basis as retail investors. For retail investors, the allocation will be restricted to a maximum of 5 percent of the notified amount. Individual investors can also place bids as per the non-competitive scheme through Retail Direct portal (<a href="https://rbiretaildirect.org.in">https://rbiretaildirect.org.in</a>).

The auction will be **Price based** using **multiple price method**. Bids for the auction should be submitted in electronic format on the Reserve Bank of India's Core Banking Solution (E-Kuber) system on **Wednesday, March 19, 2025**, during the below given timings:
